RESTART NY REGRANTS FOR NONPROFIT EVENTS

DUE: OCTOBER 1, 2021

Summary:

Restart NY Re-grants support the reopening and recovery of live, in-person public facing arts and cultural activities of artists and organizations in service to residents in Columbia, Greene, and Schoharie counties. These grants are made possible with public funds from the New York State Council on the ARTS (NYSCA), a state agency, and administered regionally by CREATE Council on the Arts.

Grants of up to \$1,000 are available for nonprofits in arts and culture in Greene, Columbia, and Schoharie Counties. This funding opportunity is for Performances, Presentations, and Public Programming in the Arts. Priority is for live performing arts projects as well as projects and events that are open to and engage public participation and audiences (ONLY Live, public events). Please note that the Restart NY Re-grants funding does not preclude an applicant from also applying for regular SCR project support as long as the projects are discrete and separate.

Eligibility:

- Applicant **MUST** be a nonprofit organization in Greene, Columbia or Schoharie Counties
- Program/Event **MUST** take place **IN-PERSON** between July 2021- June 2022 (Grant may retroactively fund past events in this timeframe)
- Applicant **MUST NOT** be funded by NYSCA directly, including NYSCA's Restart NY grant programs. (However- current recipients or applicants of CREATE's NYSCA Re-granting Program, or Greene County Initiative Program **MAY** apply.)
- Applicant **MUST** provide arts and/or cultural programs in the county in which funds are requested.
- Programs and services **MUST** benefit the residents of your respective county.
- Projects **MUST** be open to the public and **MUST** have a strong artistic component.
- The applicant's programming, administrative practice and Board membership (where applicable) does not discriminate on the basis of race, color, national origin, sex or handicap. (See also: 1991 Americans with Disabilities Act.)

Funding Can Support:

- 60% of the grant is restricted to Artists' fees for public performances and programs
- Marketing/publicity costs
- Administrative expenses
- Expendable project-related supplies and materials
- Project-related travel expenses
- Project-related rentals of space and equipment
- Consumable materials and expendable equipment cannot exceed \$1000 of the budget. (materials, expendable equipment, technology expenses, preparation/planning and training.)

Review Process:

Applications will be reviewed by a small panel of at least 3 panelists, one from each respective county in October. Notifications and awards will likely be released in late October or November.
